# Fertilizer 17-3-17

**For all applications:**

- Apply to dry foliage.
- Water in after application with a minimum of 0.2 inches to help move particles into the turf canopy.
- Do not collect clippings for at least one mowing following application to prevent particle pick-up.

**Note:** This product contains the micronutrient iron for extra greening and to help prevent iron deficiency. Iron may stain concrete and other surfaces. Misapplied product to these surfaces should be removed promptly by sweeping or blowing. DO NOT WASH OFF WITH WATER.
